To be considered for additional scholarships, submit the General Scholarship Application beginning October 1, 2025, at my.msstate.edu. The priority date for maximum consideration is December 1, 2025.

Students who qualify for and are approved for the Non-Resident Military Tuition Waiver (NRMTW) will receive a scholarship waiver for the non-resident portion of their tuition (currently valued at \$18,132) in place of the Non-Resident Scholarship, if the Non-Resident Scholarship is less than the value of the NRMTW.
